SECTION 2 — TERMS AND CONDITIONS

- 1. Commitment.** Sponsor commits to sponsoring the number of Aluminum Crane Pairs indicated in Section 1, to be designed, fabricated, and installed as part of Cranes on Parade 4 in Kearney, Nebraska.
- 2. Payment.** Full payment in the amount indicated in Section 1 shall be made payable to: Kearney Area Community Foundation | Cranes on Parade 4, prior to fabrication. Sponsorships may qualify as tax-deductible; consult a tax professional.
- 3. Installation.** Installation is performed exclusively by the COP4 Committee or its authorized designees. Location is subject to final COP4 Committee and City of Kearney approval. Sponsor has responsibility for installation on private property.
- 4. Post-Installation Repairs.** All post-installation repairs, restoration, and maintenance are the exclusive financial responsibility of the Sponsor. The Sponsor may contact the COP4 Committee or Kearney Dawn Rotary Club for guidance; however, all repair costs remain the Sponsor's sole responsibility.
- 5. Limitation of Liability.** The Kearney Dawn Rotary Club, COP4 Committee, and Kearney Area Community Foundation bear no liability for damage, loss, theft, vandalism, or deterioration of cranes after installation and make no warranties regarding post-installation condition.
- 6. Artist Pairing.** If Sponsor selects an artist, COP4 will make reasonable efforts to facilitate the pairing, subject to artist availability. COP4 reserves the right to assign an alternate artist if necessary.
- 7. Sponsor Recognition.** Sponsor will be recognized per COP4's standard practices, which may include signage, event materials, and digital promotion.
- 8. Governing Law.** This Agreement is governed by the laws of the State of Nebraska. Disputes shall be resolved in Buffalo County, Nebraska.
- 9. Entire Agreement.** This Agreement constitutes the complete understanding between parties and supersedes all prior discussions. Modifications require a written instrument signed by both parties.
